Description of Change:

In PCN-20080905-01, Sharp changed the status of the LQ084V1DG21 and LQ084V1DG22 LCD Modules to *Not Recommended For New Designs*. EOL has now been scheduled for these parts.

The replacement for both these modules is the LQ084V1DG41; currently in production. This is a mechanical and electrical drop-in replacement, but contains significant upgrades. The Table below gives specific comparisons.
